

ORDINANCE 09 - 01

**AN ORDINANCE OF THE CITY OF BELLE ISLE,
FLORIDA, AMENDING CHAPTER 30, SECTION 30-1 OF
THE BELLE ISLE CODE OF ORDINANCES DEFINING
COMMERCIAL VEHICLE AND BOX TRUCK;
PROVIDING FOR SEVERABILITY; AND PROVIDING AN
EFFECTIVE DATE.**

BE IT ORDAINED by the City Council of the City of Belle Isle, Florida, as follows:

SECTION 1. Section 30-1 of the Belle Isle Code of Ordinances, definition for commercial vehicle is hereby amended as follows:

Commercial vehicle means any vehicle designed, equipped or used for trade meeting any of the following criteria:

- a. Total signage in or on the vehicle exceeding 4 square feet in area; signage that shall be included in any measurement of the maximum area allowed shall include bumper stickers, magnetic signs, painted signs and flags. Signage that is affixed to the vehicle by the manufacturer or automotive dealer and which identifies the make, model, or dealer of the automobile shall not be included in the measurement.
- b. Equipped with external modifications designed to be used in trade including, but not limited to, externally-mounted tools, machinery, equipment, tool or equipment racks, and modifications used for purpose of lifting objects or persons above the height of the vehicles.
- c. Flatbed trucks, box trucks, and dump trucks.
- d. Equipped to tow or transport other vehicles for hire.
- e. Having a length greater than 21 feet.
- f. Having a height greater than 10 feet.
- g. A vehicle that is marked as and used for the purpose of transporting of passengers for hire such as taxicabs, shuttle vans, and limousines.
- h. Having a gross vehicle weight (GVW) of more than 10,000 pounds.

SECTION 2. Section 30-1 of the Belle Isle Code of Ordinance is hereby amended to add a definition for "box truck" as follows:

Box truck means a truck with a box-like cargo area that sits on the frame of the vehicle.

SECTION 3. SEVERABILITY. If any word, phrase, sentence, clause or other portion of this Ordinance is determined to be invalid, void, or unconstitutional, the remainder of this Ordinance shall remain in effect.

SECTION 4. EFFECTIVE DATE. This ordinance shall become effective upon adoption.
