## **Boat Ramp Registration Rules & Regulations** TO ALL WATERCRAFT LAUNCHING AT PERKINS AVENUE AND VENETIAN ISLES BOAT RAMPS

1. Ramps are for launching only, not other recreational uses including No taking turns of any watercraft particularly Jet Skis. No Skiing, Swimming or fishing from ramp areas.
2. No powering on or off trailers.
3. No starting or running of watercraft engines out of water, including jet skis.
4. No alcohol at the ramps.
5. All no wake zones must be obeyed.
6. No parking at ramps without a trailer. Parking of vehicles and watercraft trailers for use of ramp on adjacent streets is also prohibited.
7. No anchoring or mooring along shoreline of ramps and adjacent properties.
8. No fueling allowed at the ramps for any watercraft.
9. Idling at the boat ramps is prohibited.
10. No draining, cleaning, washing, repair or servicing of watercraft at the ramps.
11. No discharging of bilge pumps or popping of drain plugs at the ramps or in the water.
12. An adult must accompany persons under the age of 16.
13. No littering or disposing of food or beverages in the water.
14. All watercraft must be 24 feet in length or less.
15. Be courteous of neighbors as to noise levels and all applicable noise ordinances must be observed.
16. No trespassing o adjacent properties.
17. Dogs must be on leashes.
18. No Commercial Use for Demos or Sale or any other commercial use.
19. No Vehicles with Loud Exhaust System or No Exhaust.
20. No Spinning of Tires or Rubber on Ramp.
21. No Picnicking.
22. Use by Residents or Non-Residents without a permit May be Towed at Owners Expense and \$100 Fine.
23. No Profanity or Loud Music.
24. Breach of Rules May be subject to a fine of stiff sanction \$100-\$200 and Banning Use of Ramp and loss of permit.
25. Be Courteous to Adjoining Neighbors as to noise and all applicable noise ordinances must be observed and by obeying all of the above rules! This is our Community, Take Pride in it! Beware Area Is Under Video Surveillance. Your Misuse May Result in a Fine, and/or banned from use.
26. Any violation of any of the above rules will result in sanctions, including the loss of ramp use privileges.

I certify that I will protect the water quality of the Conway Chain of Lakes. I also agree to operate my watercraft in a safe and courteous manner. I certify that my watercraft engine is in good working condition and does not leak fuel or oil.
